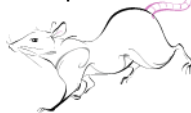

Limits:

One run per dog per class

Maximum of 60 runs/4 hours per Trial

- Barn Hunt Registration number required for valid entry. Register your dog online at www.barnhunt.com. Allow at least two (2) business days to receive a Barn Hunt number.
- Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test.
- All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically.
- Entries will be confirmed via email. Please make sure your email address is legible. If you do not receive an email, please contact the Trial Secretary.
- Day-of-Show entries will be allowed until the maximum number of runs or time has been met.
- No refunds will be made after the closing date unless there is a waiting list for entries.

Directions to Trial Site:

- Take I-15 to Pocatello Creek Road (exit 71); head east .3 miles. Turn left on Olympus Drive heading north .8 miles. Turn left onto Fairgrounds Drive. The building is .5 miles on the right.

Exhibitor Information:

- All dogs must be on a short leash and under control while on trial grounds except while showing. *Flexi leashes are not permitted inside any buildings.* Please pick up after your dog and dispose of waste in appropriate containers outside the building.

Running Order:

- Dogs will be run in height order with dogs being handled by the same person separated into different staged groups. Trials 1 and 2 will start with small; Trials 3 and 4 will start with large.
- Day-of entries will be placed in the last blind, regardless of size.

Awards:

- Ribbons will be awarded for all qualifiers in the regular classes and the Instinct test. Placement ribbons will be awarded for first through fourth place in Novice through Master. High in Class ribbons will be awarded for each class.

Miscellaneous:

- Please bring weather appropriate gear. These trials will be held indoors but the facility is affected by the outside temperature. There will be crating space available inside the building but please make sure your crate is secure as the dogs may be highly excited.
- Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. ***If bringing a bitch in season, please inform the Trial Secretary prior to the trial and inform all exhibitors at the Judge's Briefing.***
- Please bring adequate water for you and your dogs.
