Limits:

One run per dog per class; Maximum of 8 judging hours per Day

- Barn Hunt Registration number required for valid entry. Register your dog online at www.barnhunt.com. Allow at least two (2) business days to receive a Barn Hunt number.
- Dogs may enter both the Instinct Test and Novice class in the same trial until the dog has earned the RATN title and then they cannot enter the Instinct Test.
- All entries must be accompanied by entry fees to be valid. A returned check does not constitute a valid entry. There will be a \$50 fee for all returned checks. No entries will be taken over the phone or electronically.
- Entries will be confirmed via email. Please make sure your email address is legible. If you do not receive an email, please contact the Trial Secretary.
- Day-of-Show entries will be allowed until the maximum number of runs or time has been met.
- No refunds will be made after the closing date unless there is a waiting list for entries.
- Bitches in season are eligible for entry but will be required to be kept separate from all other dogs and will be run at the end of their class/trial. Entry fees for bitches that come into season will be refunded until closing time of the trial if you wish to withdraw. After the trial closes, entry fees will not be refunded. ***If bringing a bitch in season, please inform the Trial Secretary prior to the trial and inform all exhibitors at the Judge's Briefing.***

- Dogs will be run in height order with dogs being handled by the same person separated into different staged groups.
- Day-of entries will be placed in the last blind, regardless of size.

- Ribbons will be awarded for all qualifiers in the regular classes, Instinct test, and Crazy 8's. Placement ribbons will be awarded for first through fourth place in Novice through Master. High in Class ribbons will be awarded for each class.
