Footnotes from Page 1

1. Annual membership dues are \$15 per individual, \$20 per family, and \$10 per Associate, payable by January 1. Membership renewal dues must be received on or before March 1 of the same year. If payment is not received by March 1, individuals will have to re-apply for membership.
2. All membership applications must have two (2) sponsors who are members of the PKC and in good standing. If you do not know a current member of the PKC, plan to attend a meeting and introduce yourself.
3. General Meetings are held on the second Tuesday of each month, beginning at 7:00 p.m. at the Bannock Humane Society Building located at 850 Barton Road, in Pocatello, Idaho.

Membership Types

A **Regular** membership is for persons 18 years or older. A Regular member can vote and hold office.

A **Family** membership is limited to two persons eighteen years of age and older who reside in the same household. They enjoy all the privileges of the Club including the right to vote and hold office.

A **Junior** membership is for persons 10-17 years of age and shall be voted on by the Club membership. A Junior member cannot vote or hold office.

An **Associate** membership is for a person(s) who is in good standing with The American Kennel Club, and who is approved by the Club membership as deserving of the status. An Associate member has no voting rights and cannot hold office.

Application Process

1. Complete both sides of this application.
2. Mail the completed application, and annual dues, to the address below, or
Bring the completed application, and annual dues, to a General Meeting.
3. At the first meeting you attend, the application will be read to the members.
4. At the next General Meeting, there will be a second reading and vote to approve your application.
5. If your application is approved, you will be mailed or emailed the PKC Constitution, By-Laws and Standing Rules.

Waiver, Assumption of Risk, and Agreement to Hold Harmless

I understand that attendance at any training class is not without risk to myself, members of my family, guests who may attend, or my dog. Some of the dogs to which I may be exposed may be difficult to control and may be a cause of injury even when handles with the greatest amount of care.

I hereby waive and release the Pocatello Kennel Club, hereinafter referred to as the "PKC", its volunteers, officers, members, or agents from any and all liability of any nature, or for injury or damage which I or my dog may suffer. This includes specifically, but without limitation, any injury or damage resulting from the action of any dog. I expressly assume the risk of such damage or injury while attending any training session, or any other function, of the PKC, or while on the training grounds or the surrounding area thereto.

In consideration of, and as an inducement to, the acceptance of my application for training by the PKC, I hereby agree to indemnify and hold harmless the PKC, its volunteers, officers, members, and agents, from any and all claims, or claims by any member of my family, or person accompanying me to any training session or function of the PKC, or while on the grounds, or the surrounding area thereto, as a result of any action by any dog, including my own.
